Dear Sir / Madam,

With reference to the above, we wish to inform you that M/s. Deloitte Haskins & Sells, Chartered Accountants, (Registration No. 117365W), were appointed as statutory auditors of Styrenix Performance Materials Limited (formerly known as INEOS Styrolution India Limited) ("the Company") at the Annual General Meeting held on 27th August, 2020 to hold office from the conclusion of 47th Annual General Meeting till the conclusion of 52nd Annual General Meeting of the Company, at such remuneration and out of pocket expenses as may be decided by the Board of Directors of the Company.

They had requested the management of the Company, vide letter dated June 20, 2023, and the Audit Committee, vide letter dated August 8, 2023, to consider increase in their remuneration having regard to the efforts involved for the increase in scope of statutory audit. The Audit Committee, at its meeting held on August 10, 2023 did not accept their proposal for increase in the fees and rather requested them to consider reducing their remuneration for the year ending March 31, 2024, from the remuneration charged in the previous year.

We wish to further inform you that M/s. Deloitte Haskins & Sells, Chartered Accountants, (Registration No. 117365W) have expressed their inability to continue as statutory auditors of the Company vide their letter dated August 12, 2023, whereby they have tendered their resignation, with the reason mentioned in the resignation letter that the current remuneration or any reduction therein will not be commensurate to the efforts that we would be incurring to conduct an audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India.

There are neither any concerns raised by the resigning auditor with respect to the management of the Company nor there is material reason for the resignation. Hence, no deliberation on the same is required to be done by the Audit Committee and consequent disclosure of Audit Committee's view is not applicable.

The Audit Committee and the Board would consider the appointment of new statutory auditors in due course, to fill the casual vacancy caused by the resignation as aforesaid and the same would be intimated accordingly.

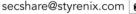

We were appointed as statutory auditors of Styrenix Performance Materials Limited (formerly known as Ineos Styrolution India Limited) ("the Company") at the Annual General Meeting held on 27th August, 2020 to hold office from the conclusion of 47th Annual General Meeting till the conclusion of 52nd Annual General Meeting of the Company, at such remuneration and out of pocket expenses as may be decided by the Board of Directors of the Company.

We had requested the Management of the Company, vide letter dated 20th June 2023, and the Audit Committee, vide letter dated August 8, 2023, to consider increase in our remuneration having regard to the efforts involved for the increase in scope of statutory audit. We have been informed vide letter dated 10th August 2023 from the Company that the Audit Committee has not accepted our proposal for increase in the fees due to the downturn in the industry and rather requested us to consider reducing our remuneration for the year ending March 31, 2024, from the remuneration charged in the previous year.

We have duly considered your request and believe that the current remuneration or any reduction therein will not be commensurate to the efforts that we would be incurring to conduct an audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India.



Accordingly we are tendering our resignation as statutory auditors of your Company with immediate effect.
